<u>General</u>

BELGAN uses Cookies to respond best to each user of the Site or the portals or forms on the Site, if

any. By using Cookies, BELGAN has better knowledge of each user's preferences and can personalize

the site to each user's expectations. The Cookies help identify each user's language of choice so that

BELGAN can automatically select that language on the Site.

What are Cookies?

A Cookie is a small text file that is stored on your computer when visiting a Site. This text file stores

information that can be read by the Site when visiting it again at a later date. Cookies can be installed

by the server of the Site you visit or by partners of that Site. A Site's server can only read the Cookies it

has installed itself and has no access to other information found in your computer or mobile device.

Cookies are stored in the folder of your browser on your computer or mobile device. Cookies generally

make the interaction between the visitor and the Site faster and easier, and help the visitor navigate

between the different parts of a Site. Some of these Cookies are necessary because otherwise the site

is unable to function properly. Other Cookies are convenient for the visitor: they remember your

username in a secure way as well as your language preferences, for example. Cookies mean that you

do not need to fill out the same information each time you visit a Site. Under no circumstances will we

use the collected data for profiling or making automated decisions about your person

Where do Cookies come from?

Based on the origin of Cookies, we make a distinction between first-party and third-party Cookies.

First-party Cookies- First-party Cookies are direct Cookies that we manage ourselves. They are

specific to the Site. It is the Site that creates and places the Cookies to function properly, for example.

Third party Cookies - Third party Cookies are Cookies that are managed or placed by a third party and

not by us. This happens during your Site visit. Third party Cookies therefore ensure that certain data is

sent to third parties through your visit of the Site. These are, for example, social media Cookies or

Cookies from advertisers, which ensure that you get to see advertisements. Although we do not

**Necessary Cookies**

**Performance Cookies**


